#### **Events:**


The safety week celebration began with a **'Safety Oath'** with all BGPL-Palghar employees. All were gathered at assembly point of Unit-II & Safety Oath was taken at 10:00 AM. Atmosphere was full of enthusiasm. The EHS Officer read the Safety Oath which was followed by all staff.

On the second day, Engineering team were gathered at the Conference Hall to attend Safety Film and lecture on 'NIHL (Noise Induced Hearing Loss)' & 'Machine Guarding'. The lecture was conducted by Mr. Hemanth Bhandary (EHS Officer) which was basically about Importance of Personal Protective Equipment's (PPEs), Effects of sound on human body, Safety during preventive maintenance, Importance of Machine Guarding & Safe Work Practices. On fourth day **Safety film on "Lab Safety & Handling of Chemical"** was shown by Mr. Hemanth Bhandary (EHS officer) which was basically about Identifying type of chemicals, Importance of Personal Protective Equipment's (PPEs), Importance of MSDS, Handling of spilled chemical & Control measures. 12 numbers of employees have attended this training. A general feedback was also taken from the participants.





On the same day, EHS Team organized **'Safety Speech Competition'** for all employees. To make the competition more exciting, the competition was judged by juries and prizes were announced for top 3 participants. Employees showed excellent response to this & delivered wonderful speech and expressed their thoughts.





On fifth day, EHS Team organized **'Spot the Hazard Competition'** for all employees. The competition was hosted by Mr. Hemanth Bhandary. The Prize was declared to be given to the winning Team. Department wise 05 teams participated in the competition. 3 Picture were shown to Participants & they have to identify the hazards shown in the picture. From 4<sup>th</sup> March to 9<sup>th</sup> March, on each day of safety week, safety committee members organized **'Safety Talks'** for each department covering all units which aimed for delivering safety related information to all shop floor employees.
